  - Parish Manager advises that the triangular parcel of land denoted in blue (Potential Expansion of Victory Park) is NOT being offered to the Parish Council at this time and is NOT part of the housing application although the developers state that it is in support of it.
  - Parish Manager advises that should the Parish Council not express an interest, in the in-development Public Open Space, it will most likely be assigned to a Management Agency with a service charge levied on the new residents.

**RESOLVED:** That the Parish Manager to advise the Planning Officer that Cosby Parish Council will consider the adoption of the in-development (red line boundary) Public Open Space should the development be approved.

Cllr: H Stevenson records her vote against the potential adoption.
